## Where is Chicago losing its iconic two-, threeand four-flats? Check out our maps to find out.

Between 2013 and 2019 Chicago lost 11,775 units in two-, three- and four-flats, according to a new study from DePaul University's Institute for Housing Studies. That figure accounts for 4.2% of the city total.


What happened to the structures tended to correlate with the part of the city in which the building was located. In areas such as North Center, Lakeview and West Town, they were often replaced with single-family homes.



But lower-cost neighborhoods also lost two-, three- and four-flats, where, in areas like Englewood and New City, they were often demolished and replaced only with vacant land, according to the study.

Total units in two-, three- and four-flat buildings lost between 2013 and 2019, by community area.








Total units in two-, three- and four-flat buildings lost between 2013 and 2019, by community area.










Total units in two-, three- and four-flat buildings lost between 2013 and 2019, by community area.








## Share of units replaced by nonresidential use
